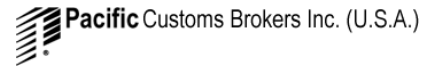

AS A TRUE AND LAWFUL AGENT AND ATTORNEY OF THE GRANTOR NAMED ABOVE FOR AND IN THE NAME, PLACE AND STEAD OF SAID GRANTOR FROM THIS DATE AND IN ALL CUSTOMS DISTRICTS, AND IN NO OTHER NAME, TO MAKE, ENDORSE, SIGN, DECLARE, OR SWEAR TO ANY ENTRY, WITHDRAWAL, DECLARATION, CERTIFICATE, BILL OF LADING, CARNET OR ANY OTHER DOCUMENT REQUIRED BY LAW OR REGULATION IN CONNECTION WITH THE IMPORTATION, TRANSPORTATION, OR EXPORTATION OF ANY MERCHANDISE SHIPPED OR CONSIGNED BY OR TO SAID GRANTOR; TO PERFORM ANY ACT OR CONDITION WHICH MAY BE REQUIRED BY LAW OR REGULATION IN CONNECTION WITH SUCH MERCHANDISE; TO RECEIVE ANY MERCHANDISE DELIVERABLE TO SAID GRANTOR;

TO MAKE ENDORSEMENTS ON BILLS OF LADING CONFERRING AUTHORITY TO TRANSFER TITLE, MAKE ENTRY OR COLLECT DRAWBACK, AND TO MAKE SIGN, DECLARE, OR SWEAR TO ANY STATEMENT, SUPPLEMENTAL STATEMENT, SCHEDULE, CERTIFICATE OF DELIVERY, CERTIFICATE OF MANUFACTURE, CERTIFICATE OF MANUFACTURE AND DELIVERY, ABSTRACT OF MANUFACTURING RECORDS, DECLARATION OF PROPRIETOR ON DRAWBACK ENTRY, DECLARATION OF EXPORT OR ANY OTHER AFFIDAVIT OR DOCUMENT WHICH MAY BE REQUIRED BY LAW OR REGULATION FOR DRAWBACK PURPOSES, REGARDLESS OF WHETHER SUCH BILL OF LADING, SWORN STATEMENT, SCHEDULE, CERTIFICATE, ABSTRACT, DECLARATION, OR OTHER AFFIDAVIT OR DOCUMENT IS INTENDED FOR FILING IN ANY CUSTOMS DISTRICT;

TO SIGN, SEAL AND DELIVER FOR AND AS THE ACT OF SAID GRANTOR ANY BOND REQUIRED BY LAW OR REGULATION IN CONNECTION WITH THE ENTRY OR WITHDRAWAL OF IMPORTED MERCHANDISE OR MERCHANDISE EXPORTED WITH OR WITHOUT BENEFIT OF DRAWBACK OR IN CONNECTION WITH THE ENTRY, CLEARANCE, LADING, UNLADING OR NAVIGATION OF ANY VESSEL OR OTHER MEANS OF CONVEYANCE OWNED OR OPERATED BY SAID GRANTOR AND ANY AND ALL BONDS WHICH MAY BE VOLUNTARILY GIVEN AND ACCEPTED UNDER APPLICABLE LAWS AND REGULATIONS, CONSIGNEE'S AND OWNER'S DECLARATIONS PROVIDED FOR IN SECTION 485, TARIFF ACT OF 1930, AS AMENDED, OR AFFIDAVITS IN CONNECTION WITH THE ENTRY OF MERCHANDISE;

TO SIGN AND SWEAR TO ANY DOCUMENT AND TO PERFORM ANY ACT THAT MAY BE NECESSARY OR REQUIRED BY LAW OR REGULATION IN CONNECTION WITH THE ENTERING, CLEARING, LADING, UNLADING, OR OPERATION OF ANY VESSEL OR OTHER MEANS OF CONVEYANCE OWNED OR OPERATED BY SAID GRANTOR;

AND GENERALLY TO TRANSACT AT THE CUSTOMS HOUSES IN ANY DISTRICT ANY AND ALL CUSTOMS BUSINESS INCLUDING MAKING, SIGNING AND FILING OF PROTESTS UNDER SECTION 514 OF THE TARIFF ACT OF 1930 IN WHICH SAID GRANTOR IS OR MAY BE CONCERNED OR INTERESTED AND WHICH MAY PROPERLY BE TRANSACTED OR PERFORMED BY AN AGENT AND ATTORNEY, GIVING TO SAID AGENT AND ATTORNEY FULL POWER AND AUTHORITY TO DO ANYTHING WHATEVER REQUISITE AND NECESSARY TO BE DONE IN THE PREMISE AS FULLY AS SAID GRANTOR COULD DO IF PRESENT AND ACTING, HEREBY RATIFYING AND CONFIRMING ALL THAT THE SAID AGENT AND ATTORNEY SHALL LAWFULLY DO BY VIRTUE OF THESE PRESENTS; THE FOREGOING POWER OF ATTORNEY TO REMAIN IN FULL FORCE AND EFFECT UNTIL NOTICE OF REVOCATION IN WRITING IS DULY GIVEN. IF THE GRANTOR OF THIS POWER OF ATTORNEY IS A PARTNERSHIP, THE SAID POWER SHALL IN NO CASE HAVE ANY FORCE OR EFFECT AFTER THE EXPIRATION OF 2 YEARS FROM THE DATE OF ITS EXECUTION.

CUSTOMS POWERS OF ATTORNEY OF RESIDENTS (INCLUDING RESIDENT CORPORATIONS) SHALL BE WITHOUT POWER OF SUBSTITUTION EXCEPT FOR THE PURPOSE OF EXECUTING SHIPPER'S EXPORT DECLARATIONS. HOWEVER A POWER OF ATTORNEY EXECUTED IN FAVOR OF A LICENSED CUSTOMS BROKER MAY SPECIFY THAT THE POWER OF ATTORNEY IS GRANTED TO THE CUSTOMS BROKER TO ACT THROUGH ANY OF ITS LICENSED OFFICERS OR ANY EMPLOYEE SPECIFICALLY AUTHORIZED TO ACT FOR SUCH CUSTOMS BROKER BY POWER OF ATTORNEY. IF YOU ARE THE IMPORTER OF RECORD PAYMENT TO THE BROKER WILL NOT RELIEVE YOU OF LIABILITY FOR CUSTOMS CHARGES (DUTIES, TAXES, OR OTHER DEBTS OWED CUSTOMS) IN THE EVENT THE CHARGES ARE NOT PAID BY THE BROKER. THEREFORE IF YOU PAY BY CHECK CUSTOMS CHARGES MAY BE PAID WITH A SEPARATE CHECK MADE PAYABLE TO THE "US CUSTOMS SERVICES" WHICH SHALL BE DELIVERED TO CUSTOMS BY THE BROKER.
